<u> Statement – 1</u>

Approved vide Resolution No. 5 by Executive Council at it's meeting held on 12-06-2014 RULES FOR ISSUE OF RANK CERTIFICATE

- Rank Certificate shall be issued in respect of all examinations except for Certificates and Diploma Courses examinations.
- 2. Rank Certificate shall be issued to the first three candidates in order of merit for each course * based on the performance at the examination(s) as stipulated. * Marks obtained at the University examination only, will be taken into consideration for the issue of Rank Certificate.
- 3. A candidate, in order to be eligible for the award of Rank Certificate, should have obtained First Division or, in the case of an examination in which no division is awarded, should have secured not less than 60% of the marks, in the aggregate.
- 4. A candidate should have passed each of the requisite examinations of a particular course of study in the first attempt along with the regular batch of candidates to which he/she belongs. Every gap, in any examination of a particular course of study will be treated as an attempt for this purpose. Improvement of performance at subsequent examinations shall not be reckoned for the award of rank certificates.

5. <u>Rank Certificate shall be issued by the University, under the following further conditions:-</u>

(A) Yearly System:-

- Rank Certificate shall be issued to candidates keeping in view their overall performance at last year's University examination (excluding internal marks of all subjects) at under-graduate courses.
- (ii) Rank Certificate shall also be issued to candidates keeping in view their performance at last year in a particular Special subject (excluding marks obtained in compulsory subject & internal marks of all subjects).
- (iii) In all Post-graduate (regular & external) examinations, rank certificate shall be issued to candidates keeping in view their overall performance at all the years of study.
- (iv) In all M. Phil. examinations, rank certificate shall be issued to candidates keeping in view their overall performance at all the years of study.

(B) Semester (CBCS) System:-

- (i) Rank Certificate shall be issued to candidates keeping in view their overall performance at all the semesters (out of total marks including credit of first to fifth semester) at under-graduate courses.
- (ii) Rank Certificate shall also be issued to candidates keeping in view their performance at last two semesters in a particular Core subject (excluding marks obtained in compulsory & other elective subjects).
- (v) In all Post-graduate examinations, rank certificate shall be issued to candidates keeping in view their overall performance at all the semesters of study.
- (vi) In all M. Phil. examinations, rank certificate shall be issued to candidates keeping in view their overall performance at all the semesters of study.
- 6. In the event of any doubt or dispute arising in connection with these rules, the decision of the Vice-Chancellor will be final.
